CHAIRPERSON'S MESSAGE

The start of a new millennium opens infinite possibilities for those who seek a brighter future. For the people involved with the Catfish Creek Conservation Authority, it means new challenges. We must continue to provide a constant level of service to the community in these times of reduced funding, and the weakening of environmental commitment by the province.

We welcome these challenges as the CCCA celebrates the 50th Anniversary of its founding on February 23, 2000, secure in the knowledge that the lessons we have learned during the last half of the twentieth century will give us the tools to fulfill our mandate for the next fifty years and beyond.

Over the past year, the Authority expanded its land management responsibilities with the acquisition of the environmentally significant Sparta Property from the County of Elgin. Thanks to the kind support of the Richard and Beryl Ivey Fund, a fund within the London Community Foundation, and the Friends of the Environment Foundation, the CCCA was afforded the opportunity to invest in a full Biological Inventory of this unique property. Fisheries rehabilitation work was instituted for the Springwater Pond, along with the reconstruction of the



Waterlily Trail at the Springwater Conservation Area. Both of these projects were helped along with the generous assistance of the Ford of Canada Community Services Committee, the Elgin Stewardship Council and the Elgin Chapter of the Friends of the Environment Foundation.

As you can see, the environmental obligations which the local community began to shoulder some fifty years ago are being realized, but only with the help of an increasing number of partners. We value this input of funding and volunteers from those who recognize and value the efforts made toward conservation in the watershed.

A large number of conservation projects remain ready to initiate, when appropriate funding becomes available. As each is completed, the natural wonders in this part of the province will be protected and nurtured. Environmentally significant lands will continue to burst forth in natural riches and the quality of life in Elgin County and beyond will continue at a level we all demand. The twenty-first century beckons us, but with the cautionary that we must never take our natural heritage for granted. It is the one factor in Canadian life which always gives generously to those who respect and protect our forests, streams, wildlife, and water resources.

50 YEARS OF CONSERVATION!

The Catfish Creek Conservation Authority is celebrating its 50th Anniversary on February 23, 2000, with an Open House at the Aylmer Old Town Hall. Support has been provided by the Aylmer & District Museum with funding through the Ontario Lottery Corporation.



HIGHLIGHTS OF 1999

FLOOD FORECASTING AND WARNING

- maintenance and operation of four water level gauges and one weather station
- channel sounding and map production to determine potential dredging sites in Port Bruce
- removed 6165 cubic yards of material from Catfish Creek in Port Bruce for flood control purposes
- installation of new stop logs in the Springwater Dam to maintain structural integrity
- pro-active Ice Monitoring Program
- operation and maintenance of the Springwater Dam
- implemented more cost effective ways and means of dealing with ice jams in the Hamlet of Port Bruce
- updated Flood Warning and Operations Plans to incorporate changes through municipal restructuring



Fisheries Assessment

ENVIRONMENTAL PLANNING

- worked to protect valley lands and flood plain areas by processing 18 permits under Section 28 Regulations of the Conservation Authorities Act
- provided environmental input to watershed municipalities by responding to 64 Planning Act applications or documents
- reviewed and provided comments on 8 Municipal Drain Reports
- further developed the Authority's Geographic Information System (GIS) Mapping
- reviewed 65 property inquiries (legal, real estate and general information)
- renewed an Agreement with the Department of Fisheries and Oceans to protect and promote healthy fisheries within the watershed
- participation in the Southwestern Ontario Municipal Drain Classification Pilot Project

COMMUNITY INFORMATION/EDUCATION

- member of the Elgin Trans Canada Trail Committee
- active participant in the newly formed Southwestern Ontario Leave A Legacy Program
- member of Volunteer Elgin
- joined the provincial Conservation Services Cooperative to access printed resource materials for distribution to landowners through the CCCA Resource Centre
- technical advisor on the Elgin Stewardship Council
- developed a web site to inform the public of Authority events and programs
- hosted a tour of the Springwater maple syrup operation for the wife of the Japanese Ambassador to Canada

- received a Recognition Award from Wildlife Habitat Canada for the preservation of the Springwater Forest
- participated in the International Year of Older Persons Community Partnership Projects Program

EXTENSION SERVICES

(Tree Planting/Woodlot Management/Soil Conservation)

- 23,600 trees planted throughout the watershed to improve air and water quality and enhance wildlife habitat
- supplied and planted native trees at various Conservation Areas through the Community Forest Program
- provided certified staff to approve Managed Forest Tax Incentive Program Plans for private landowners
- delivered large stock hardwoods to local municipalities for roadside planting
- provided landowners with technical expertise and a wide range of tree planting services
- implemented Woodlot Management Plans for local municipalities and private landowners
- design and implementation of streambank stabilization projects incorporating bio-engineering techniques
- fisheries rehabilitation projects
- Buffer Strip Planting Program

CONSERVATION AREAS

- upgraded the electrical services at the Springwater C.A.
- installation of a computerized reservation system
- completed trail improvements on the Waterlily Trail and Springwater Forest
- implemented a Reservoir Rehabilitation Project at Springwater which included the removal of Carp and drawdown of water levels to improve water quality

ENVIRONMENTALLY SIGNIFICANT AREAS PROTECTION

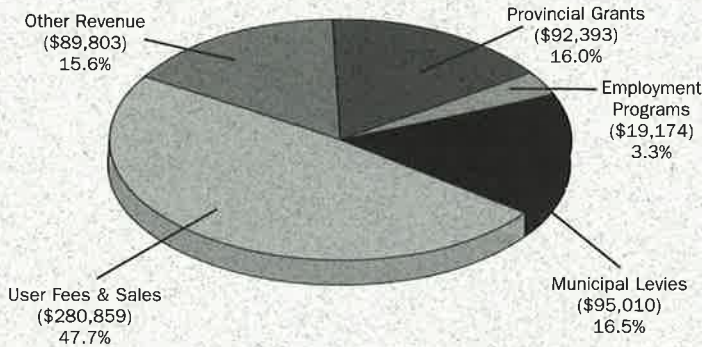
- developed stronger partnerships with national, provincial, & local agencies in coordinating significant land protection
- acquisition of the Sparta Property from the County of Elgin
- initiated a complete biological survey of the Sparta Property thanks to the assistance of the Friends of the Environment Foundation and the London Community Foundation
- hosted an Open House to gather public input for the development of a Management Strategy at the Sparta Property
- installed gates and signage for access control and permitted uses



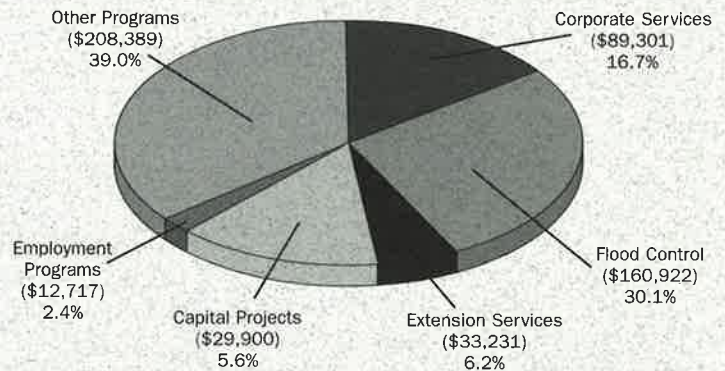
Conservation Award Winner - The Tarry Family

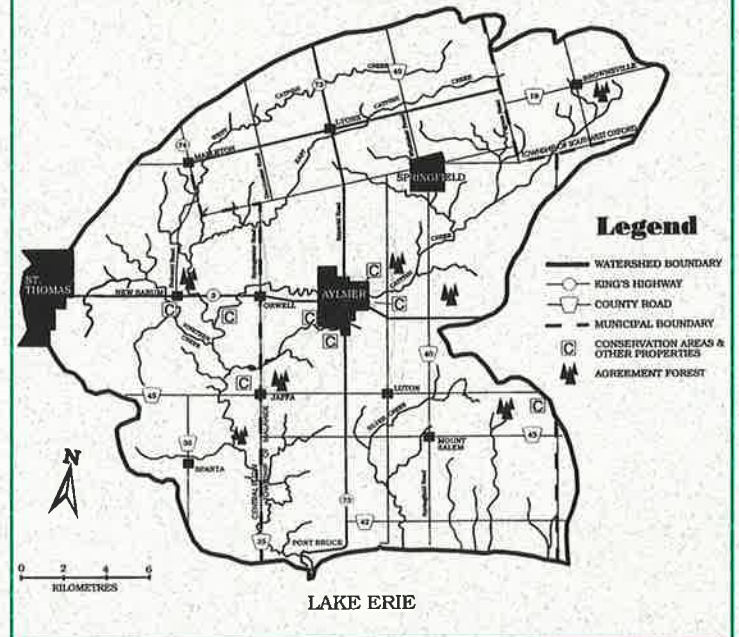
