CHAIRPERSON'S MESSAGE

As the Chairperson for the last three years, I continue to be pleased to share in the work of this strong, environmentally responsible and adapting Conservation Authority. Every member of our Board, all our staff and our many committed volunteers work well together to keep Catfish Creek Conservation Authority (CCCA) up-to-date and effective.

The CCCA has an excellent record of preserving our natural heritage and offering interpretation of it for all as well as doing all our provincially mandated work. We have undertaken a Sedimentation Study under our Ice Management Programme to help reduce flooding in Port Bruce, repaired the dam at Springwater and done restorative work on the banks of Catfish Creek in the Town of Aylmer.

Continuing our commitment to Marsh Quest, the Carolinian Forest Festival, and the Maple Syrup Programme in partnership with the Thames Valley District School Board, demonstrates our strong mandate to educate. Our excellent long-term working relationship with the Environmental Leadership Programme is vital to our education programmes and we very much value the leadership of Duncan Sinclair. Our staff, co-op students and volunteers work hard to provide excellent environmental education programmes. As well our lands continue to offer excellent study opportunities for both the University of Western Ontario and the University of Guelph.

Once again, we participated in Doors Open Port Stanley/Sparta by having the Yarmouth Natural Heritage Area open for guided tours October 1st. Our new geothermal heating and cooling ground source unit has proved very beneficial both environmentally and fiscally saving us over \$2,000 in its first year. We are a very fiscally responsible Authority receiving only 21% of our funds from municipal levies and 22% from provincial funding with the remaining 57% being self-generated. We will continue to face many challenges with the cutbacks being mandated provincially.

This year, Ric Wellwood officially announced his retirement and as an Authority we have very much appreciated his hard work for us during his tenure. He acquired in grants over one and a half million dollars for the work we do including a Celebrate Ontario Grant last year to improve and expand our Maple Syrup Festival.

It is with difficulty, I have to acknowledge the retirement from our Board of George Cleminshaw. George has been a valuable asset to our Board, serving for 17 years as Malahide's representative and my Vice-Chair for the last three years. He has been a knowledgeable, sensible and reliable member to work with and will be sorely missed. We wish both George and Ric all the best.

In closing, I want to acknowledge the excellent working relationship that has developed between the Grand River CA, the Long Point Region CA, the Kettle Creek CA and ourselves through the Source Water Protection Committee. We learn a lot from each other and work well together. Also a special thanks to the staff as well as all the volunteers, sponsors and organizations that supported and assisted CCCA in achieving its many goals. The success of the work that is done would not be possible without your dedication and commitment.

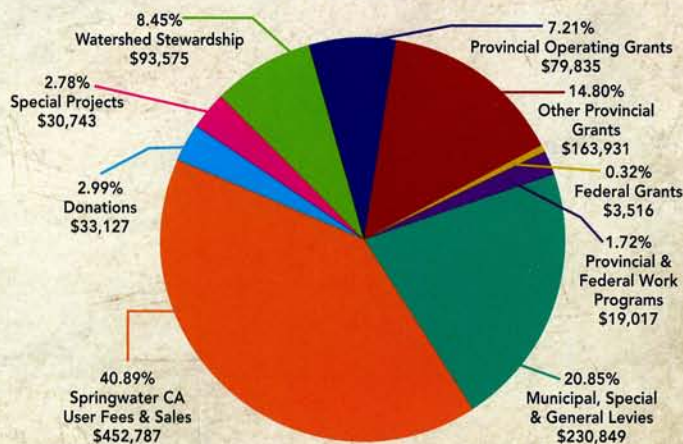

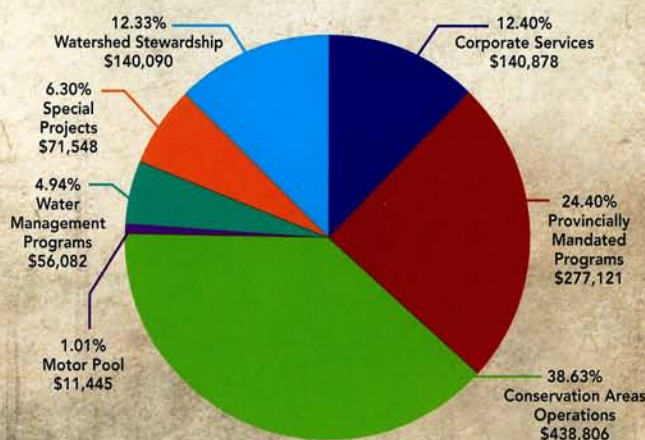

YEAR IN REVIEW...

ENVIRONMENTAL PLANNING

- Reviewed and commented on 52 Planning Act applications and development proposals
- Issued 18 permits relative to the Conservation Authorities Act, Ontario Reg. 146/06, under O. Reg. 97/04
- Received and provided comments on 7 Municipal Drain Reports and Drain Maintenance requests
- Provided responses to 59 property inquiries (legal, real estate, general information requests)
- Commented on the Official Plans being revised for the Township of Malahide and newly developed for the County of Elgin
- Assessed the impacts of the new provincial Endangered Species Act to conserve, enhance and recover endangered and threatened species in the watershed.

DRINKING WATER SOURCE PROTECTION

In 2006, the Ontario government passed the Clean Water Act to protect the wells, rivers and lakes that are sources of municipal drinking water. Under the Act, the Grand River, Long Point Region, Kettle Creek and Catfish Creek Conservation Authorities have continued their partnership under the umbrella of the Lake Erie Source Protection Region to complete Assessment Reports which will form the basis of preparing Source Protection Plans for each of the respective watersheds.

The Assessment Report for the Catfish Creek Source Protection Area is now complete and was one of the first in the Province of Ontario to receive final approval under Section 17 (2) of the Clean Water Act, 2006.

The next step is to decide what to do about the significant threats identified in the Assessment Reports.

The Drinking Water Source Protection Plans will contain the policies and programs needed to address these issues and are scheduled to be completed by August, 2012.

WATERSHED STEWARDSHIP

- Worked in partnership with Ontario Power Generation (OPG) to enhance the interior forest habitat and extend the natural heritage corridors throughout the Catfish Creek watershed by planting 30,000 native trees and wildlife shrubs

- Implemented woodlot management activities on private and public lands with the assistance of the students from the Environmental Leadership Program
- Provided approvals of Managed Forest Plans for private landowners applying to the provincial Managed Forest Tax Incentive Program (MFTIP)
- Worked with a number of community environmental partners to complete several fish and wildlife habitat restoration projects through the Community Fisheries / Wildlife Involvement Program (CFWIP)
- Received funding support from the Environment Canada "EcoAction Community Funding Program" to assist The Rotary Club of Aylmer with the second phase of the restoration of Catfish Creek in the Town of Aylmer
- Acted as the designated local resource agency to provide technical advice to farmers interested in undertaking environmental projects through the Canada-Ontario Farm Stewardship Program (COFSP)
- Provided technical expertise and financial incentives to watershed landowners for erosion control, wetland construction, and fisheries rehabilitation projects on private lands
- Re-established the Catfish Creek Irrigation Advisory Committee to monitor water taking by landowners needing irrigation for their agricultural crops

WATER MANAGEMENT

Average surface temperatures are increasing which in turn increases change to precipitation patterns and extent. Changes in climate conditions are expected to include general warming, decreased snow cover, increase in the amount of temperature extremes, and the intensity of localized precipitation. These climate changes are expected to adversely affect local communities through increased flooding and

longer durations of low water conditions. The CCCA attempts to mitigate the impacts of climate change through water management activities such as flood forecasting and low water response.

The CCCA informs partner municipalities and residents of associated water level risks. CCCA monitors and maintains a series of hydrometric stations within the Catfish Creek and neighbouring watersheds to determine the effects of precipitation, snow melt, and ice migration on water levels. Using data collected through the hydrometric network, the CCCA is able to monitor water levels and forecast channel flows which are used to notify watershed municipalities and residents of potential floods and low water conditions.

The CCCA is responsible for providing Advisories and Warnings of potential flooding events which pose a threat to watershed residents. Based on watershed conditions, the most appropriate flood message is sent to the municipalities who have the responsibility to respond and ensure the safety of their residents.

The Ministry of Natural Resources has developed a Low Water Response Plan to assist with low water conditions and support local low water response. The CCCA coordinates a Low Water Response Team which is comprised of representatives from local water user groups, member municipalities, farmers / landowners, recreation users, industry and government agencies. Within the realm of the Low Water Response Plan, the local Water Response Team makes decisions on the appropriate measures and conservation actions to be implemented.

CONSERVATION LANDS

- Partnered with staff from the Jaffa Environmental Education Centre and the East Elgin Secondary School Environmental Leadership Program to deliver the Carolinian Forest Festival and Marsh Quest to over 2,000 students
- Hosted the South West Region Envirothon Competition at the Springwater Conservation Area
- Received funding support from Shell Canada, Celebrate Ontario and the Food Safety and Traceability Initiative to enhance the Springwater Maple Syrup Festival and the trails in the Springwater Forest
- Provided technical training and hands-on work experience for students enrolled in the Environmental Leadership Program and the Cooperative Education Work Placement Program in the Thames Valley District School Board

- Planted two hectares of tallgrass prairie at the Archie Coulter Conservation Area

- Hosted a Doors Open event for the public to tour the Yarmouth Natural Heritage Area

- Managed and operated over 535 hectares of land for the purposes of active and passive recreation, species at risk protection, water recharge, environmental education, wildlife habitat and forest products.

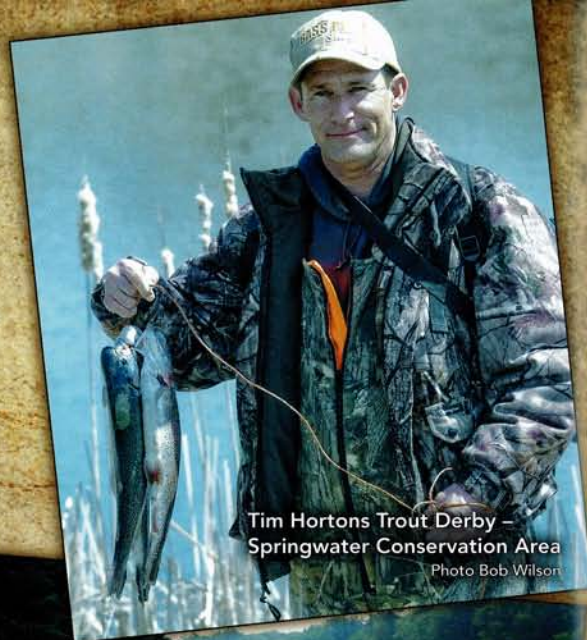
