SEASONAL SITE FEES

The CCCA Board of Directors has set the rates for the 2024 camping season. In order to maintain efficiencies, a nominal increase in camping fees was approved. A copy of the detailed Fee Schedule is available on our website.

Unfortunately, hydro abuse continues to occur in addition to the raise in employment expense leading to the higher seasonal fees. We know that not everyone will be happy with these increases and we strive to keep our seasonal fees competitive. This is a reminder that if you let us know before April 30th that you no longer wish to camp, your deposit is refundable.

Sewage Pumping (2 nd Tank Service)	50% of rate
Sewage Pumping (per pump)	\$60.00
Unscheduled / Emergency Sewage	\$125.00
Winter Storage – Trailer & Site Contents (due by Thanksgiving - October 10)	\$250.00
Winter Storage *deck &/or shed only	\$50.00
Winter Storage Late Fee (per Month)	\$ 80.00
External Refrigerator or freezer (Only 1 permitted)	\$125.00
Golf Cart Permit Fee * official Disability Permit required	\$80.00
Hydro Abuse (per Incident) * unattended trailer, outdoor lights, etc.	\$50.00

WINTER STORAGE

Any Seasonal Campers with trailers stored on-site at Springwater who will not be camping for the 2024 camping season, please note that the site **must be vacated by April 30th**. Please contact the office as soon as possible to notify of this change. Make sure to clean up the site and return entry cards to qualify for the Refundable Site Cleaning Deposit reimbursement.

May 10th, 2024 Mother's Day Weekend	- Gates Open - Hydro Turned On - Seasonal Site Fees Due in Full
May 17th, 2024 Victoria Day Weekend	- Campground Open to All
May 31st, 2023	- Late fee is applied to all past due accounts, applied at the end of each month
October 14th, 2024 Thanksgiving Monday	- Winter Storage Fees Due - Next Season Site Deposit due
October 15th, 2024	-Hydro turned off
October 18th, 2024 Friday following Thanksgiving Monday	- Gates Locked for the Season at 3:00 p.m.
