 associated with present CCCA Flood Forecasting Tools (Freezing Day Calculator for
 forecasting creek ice thickness, CCCA Precipitation Discharge Interpolator for
 available cumulative runoff vs time and Hydrometric Interpolator for forecasting
 discharge using available runoff from CCCA Precipitation Discharge relationships)
- Catfish Creek watershed hydrologic modeling using HEC (Hydrologic Engineering Centre) series of software designed to simulate the complete hydrologic processes of a watershed network, for use as a tool to replace existing modeling resources for Catfish Creek Conservation Authority (CCCA) flood forecasting and as a water resource planning tool.
- Monitoring of the CCCA administrative area for low water conditions as per the Ontario Government, Ontario Low Water Response criteria.
- Continuous:
 - Catfish Creek watershed HEC series software modeling for integration into flood forecasting and water resource planning.
 - Maintaining the Catfish Creek water quantity database for seasonal flows (flood and low water).
 - Monitoring for watershed seasonal flows (low and or high) to verify and issue Watershed Condition Statements.
 - Monitoring Lake Erie weather patterns and water levels for Lake Erie Watershed Condition Statements, coupled with evaluations for wind induced storm surge and subsequent shoreline flood conditions.

SUBJECT: Bill 5, the Protect Ontario by Unleashing Our Economy Act.

Bill 17, the Protect Ontario by Building Faster and Smarter Act, 2025

DATE: May 27, 2025

PURPOSE:

To reprise the members of recent ramifications regarding Bill 5, the Protect Ontario by Unleashing Our Economy Act.

DISCUSSION:

Over the Easter long weekend, the Ford government tabled Bill 5, the "Protect Ontario by Unleashing Our Economy Act." But behind its misleading title lies one of the most dangerous rollbacks of environmental protection in Ontario's history.

Bill 5 is a sweeping, pro-industry bill designed to fast-track resource extraction, terminate environmental oversight, and hand unprecedented power to developers, mining companies, and Cabinet ministers all at the expense of Ontario's ecosystems, species at risk, and public accountability.

This bill would repeal Ontario's internationally respected Endangered Species Act and replace it with the Species Conservation Act. The new law guts the definition of habitat, protecting only a species' immediate dwelling, like a den or nest, while leaving the surrounding ecosystem open to destruction. Forest corridors, wetlands, migratory routes, essential areas species rely on would become fair game for development.

Even worse, Bill 5 puts politicians, not scientists, in charge of deciding which species are protected. Cabinet could ignore expert advice and make politically motivated decisions that risk pushing species closer to extinction. This is not conservation. This is ecological negligence.

Bill 5 doesn't stop with wildlife. It opens the floodgates to large-scale, unaccountable development by:

- Creating "special economic zones" where developers handpicked by the province can override environmental laws.
- Fast-tracking mining approvals—especially in the sensitive and carbon-rich Ring
 of Fire region—without proper environmental scrutiny.
- Weakening environmental assessments for major infrastructure and industrial projects, removing safeguards designed to protect communities and ecosystems.

These changes amount to a systematic dismantling of the checks and balances that have protected Ontario's environment for decades.

The Ford government claims Bill 5 is about "economic independence" and "energy security." But this is a false choice. Protecting nature is not a barrier to prosperity—it's the foundation of it. Clean air, clean water, stable climate systems, and healthy biodiversity are essential to our health, food systems, and long-term economy.

Bill 5 is a clear signal that this government is willing to sacrifice environmental stewardship and science-based policy in the name of short-term profits. If passed, the damage could be irreversible—not just to species and ecosystems, but to the democratic processes that protect them.

Bill 17, the Protect Ontario by Building Faster and Smarter Act, 2025, represents the provincial government's push to accelerate development and infrastructure projects in response to economic pressures, including rising U.S. tariffs. The legislation seeks to streamline municipal development approvals, standardize development charges across jurisdictions, and fast-track transportation and transit-oriented projects. While these measures may promote investment and job creation, they also risk undermining critical environmental and planning safeguards. By centralizing decision-making and reducing local and public input, Bill 17 could strain municipal capacity, limit tailored responses to local conditions, and weaken the accountability mechanisms that ensure sustainable growth. Furthermore, the cumulative effects of Bill 17, in conjunction with Bill 5, may erode long-standing protections for natural systems and biodiversity if proper checks and balances are not retained. Therefore, while the intent to stimulate economic activity is clear, it is vital that the province ensures transparency, upholds environmental standards, and meaningfully engages stakeholders to avoid long-term consequences to Ontario's ecological and community well-being.

SUBJECT: Southwestern Regional Envirothon Competition

DATE: May 20, 2025

PURPOSE:

To provide the members with a synopsis of the Southwestern Regional Envirothon Competition held at the Springwater Conservation Area on April 29, 2025.

DISCUSSION:

The 2025 Southwest Envirothon was a one-day academic and experiential competition designed to engage high school students in environmental education through hands-on learning. The event provides a platform for students to expand their environmental knowledge while developing critical thinking, problem-solving, and teamwork skills in an interactive, real-world context.

Each Envirothon team is composed of five high school students who work collaboratively to tackle a series of challenges focused on environmental science topics. The topperforming team from the regional event advances to the Ontario Provincial Envirothon Competition.

This year's event saw strong participation, with 15 teams representing 9 different secondary schools from across the region. Participating schools included:

Thames Valley District School Board's Environmental HELP Program registered (6 teams) – a semester-long environmental leadership program open to Grade 10 and 11 students,

PURPOSE:

To update the members on the business items discussed at the Conservation Ontario Annual General Meeting.

DISCUSSION:

The General Manager / Secretary-Treasurer attended the Conservation Ontario Annual General Meeting held at the Sheraton Parkway North Hotel on April 14th, 2025. Highlights of the meeting included:

a) Election of Officers:

ChairpersonDave BartonVice-Chairperson (1)Ed McGuganVice-Chairperson (2)Pat WarrenCouncil DirectorBrad McNevinCouncil DirectorRob BaldwinCouncil DirectorChandra Sharma

b) Conservation Ontario Standing Committee Representation,

The By-laws of the Association of Conservation Authorities of Ontario state the following:

Standing Committees will work with the General Manager on operational matters to ensure that recommendations to Council reflect Conservation Authority operational viewpoints. Standing Committees and membership will be confirmed by Council decision. They may be composed of Council members and/or Conservation Authority staff specialists. They will elect their Chair and report directly to Council. The following Standing Committees are:

- 1. Budget and Audit Committee
- 2. Group Insurance and Benefits Committee
- 3. Occupational Health and Safety/Risk Management Committee

c) Conservation Ontario Representatives and; Annual Update: Committees and Conservation Authority Discussion Group,

Conservation Ontario (CO) provides an annual list of CO Representatives and Conservation Authority (CA) Discussion Groups to recognize the significant volunteer contributions provided through CA staff to collective strategic priorities.

d) 2024 Audited Financial Statements and Audit Letters,

The Budget & Audit Committee's role includes oversight of the audit process, review of the results of the external audit, recommendation of any action required in response to the Auditor's recommendation and recommendation of the appointment of the Auditors and the audit fee for the upcoming year.

Conservation Ontario's Auditors (BDO Canada) met with Angela Coleman, Lauren McPherson, and the Budget and Audit Committee on March 7, 2025, to review the Auditor's Report and Draft 2024 Financial Statements. There were no concerns identified in the Auditor's report. BDO Canada will be presenting the Audited financial statements at the April 14, 2025, Annual General Meeting. The audited financial statements are prepared in accordance with Canadian accounting standards for not-for-profit organizations. The audited statements and various letters have been reviewed and approved by staff.

e) 2025 Insurance Renewal and Committee Update

The Group Insurance and Benefits Committee met with our broker, Marsh Canada Limited, on October 3, 2024, to conduct a mid-year claims review and to provide direction related the marketing plan for the upcoming 2025 renewal. The Committee met again with Marsh on March 6, 2025, to review the insurance renewal terms for the year starting April 1, 2025. The Committee also met with Mosey & Mosey, its broker for health, life and disability insurance benefits on March 28, 2025, to receive a review of the past 10 months of experience and a forecast for the next renewal, September 1, 2025.

f) 2024 Conservation Ontario Annual Report.

The 2024 Conservation Ontario Annual Report highlights the efforts of Conservation Ontario (CO) and Conservation Authorities (CAs) in managing Ontario's watersheds, mitigating natural hazards, and promoting sustainable environmental practices. Throughout the year, CO worked closely with provincial and federal partners to enhance policy development, improve regulatory frameworks, and streamline services for increased efficiency.

g) 2025 Special Projects Budget,

The Budget & Audit Committee reviews and recommends the proposed special projects budget to Conservation Ontario Council. The committee met on March 7, 2025, to review the proposed 2025 Special Projects Budget. The 2025 Special Projects Budget is presented at the Annual General Meeting in April, rather than with the 2025 Operating Budget in September. The rationale is that special projects typically depend on provincial and federal funding and Governments [with fiscal years having a March 31st year end.

The high value of the Budget is driven by multi-year budget reporting required under the Provincial Marginal Lands Agreement, Coastal resilience Agreement, and other multi-year Provincial TPAs Funds, (most of these funds directly to partner Conservation Authorities).

h) Conservation Ontario Client Service and Streamlining Initiative (CSSI) and 2024 Permit Timelines and Regulatory Compliance Report,

Since 2019, Conservation Ontario's CSSI supported objectives to increase housing supply without jeopardizing public health and safety, or the environment. The Initiative is guided by the Client Service and Streamlining Steering Committee (GMs/CAOs) and the Timely Review and Approvals Task Force. Annual reporting on CA Section 28 Permit timelines is a core component of the CO CSSI. April 1, 2024, amendments to Ontario Regulation 686/21 under the

Conservation Authorities Act introduced a new requirement for all CAs to prepare annual reporting on CA permit statistics, timelines, and other matters of regulatory compliance. This report includes details of Conservation Ontario's support for consistent CA reporting, as well as the results of the 2024 reporting of all 36 CAs.

i) Ministry of Natural Resources and Conservation Authority Access Agreement Template,

Under Ontario Regulation 688/21, a permit is required from a Conservation Authority (CA) for specified activities within conservation areas (e.g., entering and remaining in a "day-use" permit area, camping, making excavations, etc.) Conservation Ontario was approached by the Ministry of Natural Resources (MNR) in August 2024 to discuss a standard template agreement for accessing CA lands to undertake research and monitoring activities. Pending approval, the template agreement will be provided to each CA to consider local use and adoption. Use of a

Standard Template Agreement is intended to reduce legal and administrative burden for both CAs and MNR, and support longstanding monitoring and research relationships between both agencies.

j) Adapting to Coastal Hazards Across the Great Lakes Project,

Conservation Ontario partnered with three Conservation Authorities to deliver Adapting to Coastal Hazards Across the Great Lakes (the Project). Coordinated by Conservation Ontario, the Project received funding over four years (2024-2027) through Natural

Resources Canada's Climate-Resilient Coastal Communities (CRCC) Program. While ensuring knowledge transfer, the Project will co-develop three regional coastal resilience plans to guide adaptation actions for at-risk and vulnerable communities along the coast of Northern Lake Superior, Southern Lake Huron, and Western Lake Ontario.

k) Congratulatory Letters to Elected Members of Provincial Parliament and Appointed Cabinet Ministers,

Conservation Ontario sent congratulatory letters to eight of Ontario's appointed Cabinet Ministers. This included the Ministry of Environment, Conservation and Parks, Ministry of Natural Resources, Associate Ministry of Natural Resources and Forestry Products, Ministry of Municipal Affairs and Housing, Associate Ministry of Municipal Affairs and Housing, Ministry of Agriculture, Food and Agribusiness, Ministry of Red Tape Reduction, and Ministry of Rural Affairs.

I) Resilient Agricultural Landscape Program – Marginal Lands Initiative,

Conservation Ontario is delivering the Marginal Lands Initiative, a program funded by a \$12 million investment over four years from the governments of Canada and Ontario through the Sustainable Canadian Agricultural Partnership (Sustainable CAP). The Marginal Lands Initiative will support farmers by providing technical expertise from organizations specializing in agri-environmental planning to support the implementation of practices that reduce Greenhouse Gas (GHG) Emissions, sequester carbon and increase Ecosystem Goods and Services.

m) Conservation Ontario's comments on "Enabling the Development of Commercial-Scale Geological Carbon Storage in Ontario: The Geological Carbon Storage Act" (ERO# 019- 9299)

On November 25, 2024, as part of the Bill 228 Resource Management and Safety Act, 2024, the Ministry of Natural Resources introduced a proposed Geological Carbon Storage Act, which, if passed, would enable the permanent storage of carbon dioxide within geological formations. This report provides an overview of Conservation Ontario's response to the recent consultation.

n) Conservation Ontario's comments on the "2016-2020 Cumulative Impact Assessment under the Great Lakes-St. Lawrence River Basin Sustainable Water Resources Agreement (ERO#019-9455),

The Great Lakes-St. Lawrence River Basin Sustainable Water Resources Agreement ("SWRA") establishes requirements to conduct cumulative impact assessments to present water budgets for the Great Lakes basin, and individual lakes within the watershed basin. In June 2023, a five-year cumulative impact assessment (2016- 2020) was published by the Great Lakes-St Lawrence River Water Resources Regional Body and Great Lakes-St. Lawrence River Basin Water Resources Council. The Ontario

Water Resources Act requires reports to be published to the Environmental Registry, inviting public feedback on the actions Ontario should take in response.

o) Re-Launch of the Drainage Act and Section 28 Regulations Team (DART),

In 2012, the province released the Drainage Act and Conservation Authorities Act Protocol ("Protocol"). This Protocol was developed based on the advice of the interagency Drainage Act and Section 28 Regulations Team (DART). The DART team was active for many years supporting implementation of the Protocol. Through conversation, it is clear there is a need for organizations to meet more frequently to discuss drainage activities. Conservation Ontario will host a meeting of the group in April.

p) 2025 Latornell Conservation Symposium,

For three decades, the Latornell Conservation Symposium has been a vibrant forum for Conservation Authorities, environmental leaders, practitioners, and advocates dedicated to watershed management. This report provides information on the two-day experience.

q) Policy and Planning Program,

This report provides updates on Member Services provided by Policy and Planning staff since December 9, 2024, Council Meeting. The services provide focus on supporting the Conservation Authorities Act (CAA) implementation and Great Lakes Coastal Resilience.

r) Business Development and Partnerships Program,

Conservation Ontario Business Development and Partnership activities since December 2024 have supported several Conservation Authority business areas and initiatives, including advocating for and securing investments and partnerships, policy input, and project management. Highlights are provided in this and other reports in this Agenda. This report provides an update on engagement with partners at events and initiatives.

s) Drinking Water Source Protection Program,

The Clean Water Act received Royal Assent in 2006, establishing the Drinking Water Source Protection (DWSP) program administered by the Conservation and Source Protection Branch (CSPB) of the Ministry of the Environment, Conservation and Parks (MECP). The program is funded by the province. Conservation Ontario (CO)provides coordination and support to Conservation Authorities (CAs) as Source Protection Authorities (SPAs) who deliver and implement this program on a watershed basis.

t) Marketing and Communications,

The PaRx program, also known as the "Park Prescriptions" program, is a national health initiative that encourages healthcare professionals to prescribe time in nature as part of patient treatment plans. Led by the BC Parks Foundation, this innovative approach has demonstrated significant health benefits and presents an excellent opportunity for Conservation Authorities (CAs) to play a crucial role in promoting community well-being by encouraging people to spend time outdoors and in Conservation Areas.

u) Information Management Program,

This report provides an update on key information management activities involving Conservation Ontario and Member CAs. The report highlights Information Management-related initiatives that were endorsed by the Council through the Conservation Ontario Strategic Plan.

Dear Chair Babikian and Honorable Members of the Standing Committee,

Verbal Presentation to Standing Committee:

My name is Angela Coleman and I am the Chief Administrative Officer of Conservation

Ontario. Conservation Ontario is the member service organization for Ontario's 36 Conservation

Authorities, located across the Province, on a watershed basis.

I deeply respect and acknowledge the submissions of my co-presenters, on this panel. I am honored to share this space with you and recognize the significance of your comments as rights holders while my comments are from a stakeholder perspective.

Conservation Authorities work directly with the Province, Member Municipalities, partners and communities, to protect people and property from: natural hazards [such as: flooding, erosion, and landslides]; maintain flood and erosion control infrastructure; maintain sensitive lands and Conservation Areas for public benefit; protect municipal drinking water; and offer watershed enhancement, protection, and restoration projects (including agricultural and business stewardship projects, wetland projects, grassland and tree planting projects, and land securement).

Opportunity to review Conservation Authority Individual Submissions

Many Conservation Authorities have made individual submissions on this Bill. Members, if you review these submissions, you will gain perspectives from individual Conservation Authorities: many provide more detailed comments than my time permits today – so I invite you to review those.

Government Proposal

The Ministry of Economic Development, Job Creation and Trade Environmental Registry of Ontario (ERO) posting, Bill 5, the Protect Ontario by *Unleashing our Economy Act*, 2025, proposes to amend existing and enact new legislation, including the *Special Economic Zones Act*. Upon proclamation, the *Special Economic Zones Act* will provide regulation-making authorities to the Lieutenant Governor in Council (LGIC) and applicable Minister to make criteria for and to designate "special economic zones", "trusted proponents", and "designated projects". Specific definitions of these terms have not been provided with the proposed Bill.

Once established, *designated projects* undertaken by *trusted proponents* in *special economic zones* may receive exemptions or modifications to specified legislative or regulatory permitting, approvals, or other similar requirements. The proposed legislation may apply in any area of Ontario, and to any provincial Act, regulation or instrument, including municipal by-laws.

Conservation Ontario reviewed and received many comments and concerns on the proposed legislation; however, today, with limited time, I will focus comments directly on our specific legislative frameworks under the *Conservation Authorities Act* and *Clean Water Act*.

General Comments

- 1. Protecting Public Health and Safety Supports Economic Prosperity: Providing strong protections for people and property from risks related to natural hazards and existing and future sources of municipal drinking water are essential to support economic development and safe and prosperous communities. Conservation Ontario recommends that natural hazard permitting requirements under the *Conservation Authorities Act* and policies set out in the source protection plan under the *Clean Water Act* continue to apply in any designated special economic zones. The continued application of these regulations and policies will balance potential risks and further support safe and healthy communities.
- 2. Support for improved processes: Conservation Ontario and the 36 Conservation

 Authorities (CAs) share the government's commitment to identify process improvements
 and provide timely approvals to support development priorities. We are committed to
 supporting a strong provincial economy, safe housing and critical infrastructure
 development, and safeguarding sources of municipal drinking water. We believe that
 efficient permitting can be achieved while maintaining these important shared priorities.

Recommendations

1. <u>Natural Hazards Protection:</u> Ontario's natural hazard regulatory framework protects housing, critical infrastructure, and the public from natural hazard impacts, including flooding and erosion. The success of Ontario's hazard management framework and the Conservation Authority model is recognized for minimizing flood hazard risks to housing compared to other provinces in Canada, [even though we have the most housing starts in Ontario], resulting in considerably lower insurable losses. This coordinated, hazard, risk-

- based framework is supported by Ontario's Special Advisor on Flooding in their report "An Independent Review of the 2019 Flood Events in Ontario".
- 2. <u>Municipal Drinking Water Protection:</u> Conservation Authorities support protecting sources of municipal drinking water as Source Protection Authorities (SPAs) under the *Clean Water Act*. Protecting drinking water sources from Ontario's lakes, rivers, streams, and underground aquifers is critical to economic prosperity. All Source Protection Plans are approved by the Minister of Environment, Conservation and Parks.
 - Maintaining high protections established under the *Clean Water Act* ensure strong legislative and regulatory protections apply to safeguard drinking water quantity and quality. Ontario's multi-barrier approach to ensuring the safety of drinking water is strongly supported by Justice O'Connor in the 2002 *Report of the Walkerton Inquiry*.
- 3. Applying Protection Provisions in Special Economic Zones: Given the risk to public health and safety from natural hazards and extreme weather events we recommend: the Provincial Planning Statement natural hazard policies; *Conservation Authorities Act* permitting requirements; and source protection plans under the *Clean Water Act* apply in any potential *Special Economic Zone*.
- 4. <u>Technical Expertise and Expereince:</u> Conservation Authority staff bring decades of specialized expertise balancing development pressures and finding local solutions to complex matters. Both Conservation Ontario and Ontario's 36 Conservation Authorities welcome opportunities to ensure provincial development priorities are planned and implemented safely, supporting long-term economic prosperity and a healthy environment.

Thank you for the opportunity to review and provide comments on the "Special Economic Zones Act, 2025" (ERO#025-0391). I am pleased to respond to any questions you have at this time.

Bill 5, the *Protect Ontario by Unleashing our Economy Act, 2025* proposes interim amendments to the *Endangered Species Act, 2007* (*ESA, 2007*), and later repeals the *ESA, 2007* and enacts the new *Species Conservation Act, 2025* (*SCA, 2025*), once proclaimed.

Conservation Ontario supports the connection between species at risk (SAR) protection, ecosystem resilience, and social and economic well-being.

The proposed interim amendments and enactment of the *SCA*, *2025*, remove the requirement for the Province to prepare recovery strategies, management plans, and government response statements. As part of the proposed *SCA*, *2025*, the Province reaffirmed a commitment to invest in SAR conservation through the new Species Conservation Program.

This program replaces the Species at Risk Stewardship Program and increases funding to support voluntary SAR protection and conservation activities by up to \$20 million per year. As proposed, the new program would support a wider breadth of conservation activities, including SAR habitat preservation, rehabilitation and enhancement, public education and outreach programs, and other activities to assist in the protection and conservation of species.

Conservation Ontario supports the Province's collaboration with partners and agencies to facilitate timely, targeted, on-the-ground activities contributing to SAR recovery and habitat protection. Conservation Authorities are collectively the second-largest landowner in the Province of Ontario, owning and managing a diverse portfolio of natural landscapes that support, among other objectives, SAR and their habitats. Through the proposed Species

Conservation Program, and given eligibility for funding, Conservation Authorities stand ready to prioritize activities that protect and conserve SAR and their habitat, while contributing to species recovery.

Thank you for the opportunity to review and provide comments on "Proposed interim changes to the Endangered Species Act, 2007 and a proposal for the Species Conservation Act, 2025" (ERO#025-0380). Conservation Ontario and Ontario's 36 Conservation Authorities look forward to opportunities to work alongside the Province and other partners to provide continued protection, conservation and recovery for SAR and their habitat in Ontario. We would be pleased to further discuss these comments at your convenience.

Submission to the ERO for 025-0416 and to the Standing Committee on the Interior RE: Bill 5: Protect Ontario by Unleashing Our Economy Act

The Ontario Headwaters Institute, a provincial corporation with charitable status, promotes watershed security in Ontario, which we define as healthy and resilient watersheds that protect regional ecological integrity, social wellbeing, and economic vitality.

One of our key current efforts in this regard is publishing a series of position papers on the need to replace Ontario's diluted, fragmented, and ineffective approach to land use and watershed planning with an **Outcomes-based Framework for Watershed Security**. You can find an introduction and the first three position papers at https://ontarioheadwaters.ca/watershed-security-project-updates/.

Not only would prescribed ecological outcomes safeguard our watersheds, biodiversity, public health, and economic vitality, a framework identifying a clear lead agency for the outcomes would deliver goals that the Ontario government has been talking about since 2018: stream-lined, more effective environmental management.

Toward that common goal, we provide the following 8 comments and 6 recommendations.

Comments

- 1. The OHI appreciates that there is a housing crises and supports the need for action. That action should be based on the principles of a low carbon economy and complete communities, and should not be taken at the expense of the environment nor traditional democratic and legal rights.
- 2. We have, on many occasions, expressed support for potential efficiencies across environmental legislation, regulations, and agency actions. The government has never asked for any help with that.
- 3. Unfortunately, the Ontario government has for years conflated the need for action on housing with a non-scientific desire and policy bias to reduce rather than adjust environmental safeguards to make them more effective while supporting ecologically and economically unsustainable sprawl development.
- 4. Regarding changes to the mandate and role of conservation authorities and efforts to increase municipal housing starts, the OHI firmly believes that it is not possible to separate land use and watershed planning. Cutting corners on today's watershed protections will harm future environmental integrity, agriculture, biodiversity, social wellbeing, public health, and economic vitality.
- 5. Over the last several years, the Ontario government has also run roughshod over democratic and legal norms. This has included efforts to amend as many as 40 acts and regulations in omnibus bills; to create special by-law areas in which the Clean Water Act would have been suspended; backdoor efforts to alter the Greenbelt; the profligate use of Minister's Zoning Order to end run normal planning; and restriction of who can appeal development issues to the Ontario Land Tribunal.
- 6. The use of omnibus bills has been particularly deleterious to Ontario society. Organizations seeking meaningful consultation have been given limited opportunity to address the government, while there has been extensive disaffection from First Nations on the government's duty to consult.

- 7. Indeed, the consultation process has been so broken that the government's haste to impose its will has often resulted in third reading just minutes after meetings of standing committee, and/or the close of postings on the Environmental Registry of Ontario (ERO), with no time for the serious consideration of any deputations or submissions. This behaviour is antithetical to meaningful consultation and maintaining the trust of the public.
- 8. Bill 5 may be the worst omnibus effort to date. Its many failings have been well-documented by First Nations, a wide range of civil society, and in the media. In addition to the by-now normal subjugation of the environment to development, the invention in Bill 5 of "trusted proponents: and/or "designated projects" in "special economic zones", none of which have any meaningful definition but are at the discretion of an order in council. These initiatives represent a significant abrogation of Lord Durham's recommendations for responsible government and the rule of law in Ontario.

Recommendations

I The government should listen to the extensive concerns expressed by the public, policy experts, and First Nations and withdraw Bill 5.

In addition, the OHI urges the government to consider the following additional, constructive recommendations for sustainable development in a vibrant Ontario, each of which needs extensive consultation.

- II Develop provincial standards similar to the guideline in the federal publication "How Much Habitat is Enough" while working to better implement Ontario's Biodiversity Strategy.
- III Restore / renew A Wetland Conservation Strategy for Ontario, 2017–2030.
- IV Require municipalities to integrate land use and watershed planning, perhaps based on the eight actions found at https://ontarioheadwaters.ca/wp-content/uploads/2025/04/Integrating-Land-Use-and-Watershed-Planning-through-a-Municipal-Charter-April-22-2025.pdf.
- V Reduce the impact of secondary land conversion (the conversion of farms, at an average loss of 319 acres a day, as well as old aggregate sites to impervious surfaces) by expanding the role of conservation authorities and Conservation Ontario, with support from appropriate ministries, to lead a massive effort to identify where to enlarge or create new Greenbelt-style core and corridor natural heritage areas as a counter-balance to the extensive development now taking place across South-central Ontario, especially in areas of anticipated high population growth.

This initiative would constitute the basis of a multi-generational effort to safeguard our watersheds, their biodiversity, and agricultural land; reduce environmental risk and avoid the future costs of reduced natural assets; and help deliver nature-based solutions to address the climate and biodiversity crises.

VI Increase the commitments in the Planning Act and the Provincial Planning Statement, as well as in similar initiatives, for sustainable planning, sustainable communities, and sustainable buildings.
